## NOTICE OF THE MEETING OF THE GOVERNING BODY OF THE CITY OF HEMPHILL, TEXAS

Notice is hereby given that a Regular Meeting of the governing body of the above-named City will be held on Tuesday, March 19, 2019 at 4:30 P.M. in the City Council Chambers located at 211 Starr St., Hemphill, Texas, at which time the following subjects will be discussed, to-wit:

- 1) The City Council meeting will begin one hour earlier at 4:30 pm to allow the city council to meet with Billy Williams, Engineer, and Chad Montgomery of Anixter, Inc. to discuss the possibility and benefits of the City adding a Demand Charge to Commercial Electric Customers with 50KVA transformers and above. In order to allow time for this presentation, which will take approximately an hour, the meeting will start at 4:30 pm with this presentation and with questions from the council, city manager, city electrical supervisor, and citizens. The Regular part of the City Council meeting will begin after that at approximately 5:30 pm.

- 6) Hemphill Housing Authority Status Report and Update—HHA Board Members: Belinda Gay or Whitney Thomas.
- 7) Discuss improvements to the City Park with budgeted city funds and other needs for the Capital projects/Park improvement budgeted funds, which include:
  - a. A new metal roof on existing pavilion and lighting; and
  - b. A new smaller pavilion with a slab, metal roof, lighting, and picnic tables.

- 10) Discuss and Possibly Approve adding a Demand Charge for Electricity to Commercial Customers with 50KVA transformers and above, and, if added, discuss the proposed effective date that the demand charge will be added.
