Notice is hereby given that a Regular Meeting of the governing body of the above-named City will be held on Tuesday, June 16, 2020 at 5:30 P.M. in the City Council Chambers located at 211 Starr St., Hemphill, Texas, at which time the following subjects will be discussed, to-wit:
